1. Call the meeting to order by Board Secretary Fischer
a. Board Secretary Fischer called the meeting to order at 6:30 P.M.

2. Approval of Agenda

3. Public Hearing
a. Public Hearing on District Budget for the 2022-2023 school year. This is the time and place for the public hearing for the fiscal year 2023 Proposed Budget and to certify the budget and tax levy rates by April 15, 2022.

b. Public Hearing for Certified Budget Amendment 2021-2022 fiscal year. This is the time and place for the public hearing amending the certified budget for fiscal year 2021-2022. Doing so allows the district to comply with the Code of Iowa, which requires that school district expenditures not exceed the "published" budget in any one of the four functional areas.

c. Public Hearing on the K-12 School Calendar for 2022-2023 school year. This is the time and place for the public hearing and for the meeting on a day versus hours with a start date of August 23rd school calendar for the 2022-2023 school year.

7. Certified Budget Amendment 2021-2022 Fiscal Year
a. The amendment is based on estimates of expenditures from increased receipts and balances not budgeted or considered in the current budget. There will be no increase in taxes to be paid in the fiscal year ending June 30, 2022. The budget certification has four legal expenditure classifications for all District funds taken as a whole, including the General Fund, Management Fund, PPEL Fund, Capital Projects Funds, Debt Service Fund, Student Activity Fund, Food & Nutrition Fund and Day Care Fund. Each classification has been amended to a level sufficient to allow the District to spend beginning balances and unanticipated miscellaneous income. Amending the budget in this fashion on an annual basis allows the district to comply with the Code of Iowa, which requires that school district expenditures not exceed the "published" budget in any one of the four functional areas.

b. Recommendation: Approve the amended 2021-2022 certified budget as presented

8. 2022-2023 Fiscal Year Certified District Budget
a. The Board of Education is required by State Code to publish a fiscal year 2023 Proposed Budget, hold a public hearing, and certify the budget and tax levy rates by April 15, 2022. The Fiscal Year 2023 Proposed Budget is premised on Supplemental Assistance (SSA) growth of 2.5%, which was approved by the legislature and signed by the Governor.

b. The District Fiscal Year 2023 levy rate is proposed to be \$10.99 per \$1,000 of taxable valuation. On March 21, 2022 the Board of Education approved publication of the proposed Fiscal Year 2023 District budget and scheduled a public hearing on Monday April 11, 2022 to allow public comment regarding the Fiscal Year 2023 District budget with a proposed total levy rate of \$10.99955.

c. Recommendation: Recommended that the Board of Education approve the proposed Fiscal Year 2022- 2023 District Budget with a proposed total levy rate of \$10.99955.
